The minutes of Lezayre Parish Commissioners meeting held on Thursday 1st June 2017, at 7.15pm, The Community Hall, Clenagh Road, Sulby, Lezayre.

Members present: Mrs. V A Quane, Mr. A D Radcliffe, Mr K Brew, Miss V Radcliffe and Mr J Teare. Mrs. M Rimmer the Clerk took the minutes. There were no members of the public and no members of the press in attendance.

The minutes of the previous meeting held on the 4th May 2017, having being circulated, were taken as read and signed as a correct record by the Chairman.

Matters arising from the minutes

Mr Teare advised the members that he had reported various items as discussed at our last meeting to the NTLGM. Our concerns regarding the differing weight limit signs for the Clenagh Road were to be looked at, with appropriate additional wording. Crossroads warning signs and white line painting for the Kella/Curragh Road are on the list to be carried out. The verge monitors advised missing on the Sulby Glen Road by the Waterworks building are also to be looked at.

The clerk advised that she had heard back from USM regarding tipping on Sky Hill land. This is to be removed. Mr Brew will check if removed when next in the area.

Mr Brew reminded Mrs Quane to remove the orange fencing to the rear of the container.

The clerk advised the members that she had spoken to John Quayle regarding the placing of parish boundary signs for Ballaugh. He asked for us to write to the Commissioners with our ideas. The members asked the clerk to write as directed.

Mrs Quane reported that the Parish boundary sign on the St Judes Road was not facing in the right direction. Mr Brew agreed to take a look.

The clerk advised that she had not yet heard back from the MUA regarding the condition of our wooden pole street lights, but had been advised that in the event of a pole falling down we would be responsible, unless someone else caused the pole to fall down or there was some negligence on the part of the installer (MUA) If the pole has overhead lines fixed, that would be MUA too. Mr Brew advised the members that he had taken the time to experiment with the wooden poles on the land to the rear of the hall placing them to show the extent of the car parking area. The members agreed to take a look at this and bring feedback to our next meeting.
